**Entries close Friday 18<sup>th</sup> July 2025 or when pens are full.**

**Please send entries to Charters Towers Show, PO Box 141, Charters Towers QLD 4820 or bring them into Show Office (under grandstand) anytime, between 10am – 4.30 pm but NOT after Friday 18<sup>th</sup> July 2025.**

**CONDITIONS OF ENTRY:**

- 1) All birds to be penned by 8.00am Monday 28<sup>th</sup> July 2025. Judging will start from 9.00am.
- 2) Sick or diseased birds will **NOT** be allowed to be penned.
- 3) Infected birds will be removed from the pavilion to the exhibitor at the exhibitor's cost. If the exhibitor is not available, the infected bird/s will be quarantined at the exhibitor's cost.
- 4) Any poultry with stick fast fleas needs to be removed and spraying of all pens be done at the owner's expense and will not be allowed to show.
- 5) No bird is to be handled or removed from the pen without a Steward's permission.
- 6) Cockerels and pullets must be under 12 months at the time of showing.
- 7) Fowl exhibits – Please show breed on entry form.
- 8) All birds will be watered during the Show.
- 9) No bird shall be released from the Show before 3pm on the last day of the Show (Tuesday) 29<sup>th</sup> July 2025.
- 10) Prize money may be collected from the Steward between 3.30pm and 4.00pm on Tuesday 29<sup>th</sup> July 2025.
- 11) Entries in AOV and AOC classes must have a description of breed, colour and sex on the entry form.
- 12) Entries in the juvenile classes must be penned by the juvenile exhibitor.**
- 13) Birds entered into the wrong class by the exhibitor may be changed to the correct class by the judge and/ or chief steward.
- 14) The Poultry shed is Alcohol Free, if exhibitors are wanting to consume alcohol there is a bar on the grounds.
- 15) TPA&MA Inc. will not be responsible for any accidents, damage, death, loss, alteration or omission that may be caused through or by, an exhibit or exhibitor, and it shall be a condition of entry that such exhibitor will hold the Association blames and indemnified against legal proceedings arising out of such accident, damage, death, loss, alteration or omission. If you are unsure about the effect of this clause, please seek your own legal advice at your own cost prior to entering your exhibit.
- 16) The judge's decision is final and no discussion will be entered into with the judge while judging is in process about their decision or the merits thereof.
- 17) TPA&MA Inc. reserves the right to substitute vouchers/sponsor's goods for the prize money for voucher's/sponsor's goods.
- 18) Any person objecting to an award or an exhibit can enter a protest in writing, setting out the grounds for the objection. The protest must be lodged with the TPA&MA Inc. via the Secretary before noon Tuesday 29<sup>th</sup> July 2025. No protest will be entered without reason provided. Protests must be accompanied by the sum of \$50.00, which will be forfeited to TPA&MA Inc.

Dispute Resolution Committee should the Committee find the protest frivolous or vexatious. The Committee's decision is final.

## CHILDRENS SECTION

The Committee is again inviting school – age children to participate in activities in the Poultry and Pigeon Section of the Show. Parents can assist TPA&MA Inc. by encouraging children to take part in this section by exhibiting a recognised breed of fowl or bringing in a few backyard chooks to join in.

All fowls entered into the Show must be free of lice and vermin and be healthy. Any obvious health problems will require the Stewards to request the removal of the exhibit from the Show. All conditions applying to the adult sections, apply to the Children's section. Adults need to sign a consent form for children to enter and indemnify TPA&MA Inc. as if it were an adult entry. And to make the Show fun for kids of various ages, we have included a class for decorated eggs in a basket, a hanging mobile for two age groups and plus an egg carton creation – this can be anything made from an egg carton or cartons. Eggs can be of any size and have any form of decoration **but please hard boil the eggs first before decorating. Entry Fee 50C.**

**CONDITIONS:**

1. **ADVERTISING SIGNS:** The display of approved advertising of any description is restricted to the area occupied by the exhibitor. No permanent sign to be erected.
2. **CAMPING:** ONLY LIMITED CAMPING IS AVAILABLE ON THE Showgrounds and will be allocated as each application **AND PAYMENT** is received until available areas are filled.
3. **DISPLAY FASTENINGS:** Under no circumstances shall the exhibitor excavate, dig, or place pegs in his/her area without first obtaining authority from TPAMA Inc. Securing the floor coverings is to be by removable tape only. Nails screws or bolt fastening into concrete floors or walls of the buildings are not permitted.
4. **DISPLAY LAYOUT:** TPA&MA Inc. Undertakes to the rent the site and/ building there upon in their present conditions. All subsequent plumbing, carpentry and electrical requirements will be responsibility of the exhibitor. Erections of structures of a permanent nature are not permitted. All temporary structures must be removed after the Show.
5. **DOGS/ANIMALS:** Any dogs or other animals, not restrained, or acting in a manner to cause a nuisance to the public or to other campers or competitors will be removed without notice by the Officers of Regional Council.
6. **ELECTRIAL:** If more than one 10amp power point is required, a four board with sufficient surge proctor is allowed on the condition that it has an overload facility. All leads must be tagged and tested and be clear of the ground/floor and must not impede the flow of pedestrians.
7. **EXHIBITOR'S CONDUCT:** Exhibitor's must conduct themselves in an orderly and respectful manner while they are on the Showgrounds. Alcoholic beverages must not be consumed on sites by site holders or workers. Disturbances must be reported to the TPA&MA Inc. Space Steward.
8. **INDEMNITY:** The TPA&MA Inc. Will not be held responsible for any accident which may be caused through or by the site holder, or which may happen in connection with his/hers business and the site holder shall declare the TPA&MA Inc. Blameless and indemnify it against any legal proceedings arising from such an act/omission or accident. A copy of your current, paid, public liability insurance noting the TPA&MA Inc. as an interested party for the duration of the Show is a mandatory requirement for trade space at this Show.
9. **LOSS OR DAMAGE:** The TPA&MA Inc. Will not be, under any circumstances, be held responsible for any loss of, or damage to, stock in trade, be it by theft, fraud etc or any part thereof of any site holder or exhibitor.
10. **OFFENSIVE/ILLEGAL MATERIAL:** The Trade Space Steward or Executive Members of the Management Committee **shall have the power to enter sites** and remove an article, sign, picture or other printed matter which, in their opinion, may cause offence to the public or officials of TPA&MA Inc. or are items banned by the Queensland Chamber of Agricultural Societies (QCAS). A list is available on request from the Secretary.
11. **RAFFLES/GAMING:** Gambling, disposal of any article by lot or chance and the sale of art union tickets are strictly prohibited except on those sites specifically allocated for that purpose. Exhibitors must not allow their areas, other than those specified, to be used for fundraising raffles even though the exhibitor is sponsoring a charity.

12. **RUBBISH REMOVAL:** All exhibitors must have litter bins which must be emptied into the TPA&MA Inc. litter bins after the Show closes daily. Site holders are totally responsible for all cleaning on or around the adjacent to their site for the duration of the Show. Should a site be left in an unclean and/or unsanitary or cluttered condition an extra cleaning charge may be levied. Remember, a tidy and clean place will attract visitors.
13. **SOUND SYSTEM:** P A Systems, projectors and sound units must be governed so their volume is not objectionable to other exhibitors or Show patrons. The TPA&MA Inc. will order

objectionable systems disconnected on receipt of legitimate complaint. The discretion to determine what is defined as a legitimate complaint.

**14. STALL REGULATIONS:** All stalls must be constructed and maintained in accordance with the appropriate state and city department's regulations. It is the responsibility of the applicant to see that all permits and inspections have been obtained and carried out. Such certificates must be furnished if/when requested by the TPA&MA Inc. Space Steward or TPA&MA Inc. Committee, The Stallholder, regardless, warrants to TPA&MA Inc. That all their stalls are constructed to Australian Standards regarding construction, legality and safety.

**15. SUB-LETTING:** Subletting is not allowed without written permission from the TPA&MA Inc. Secretary. The allocated space is to be used only for the purpose described in the application form and his/her employees or volunteers.

**16. WORKPLACE HEALTH AND SAFETY REGULATIONS AND INSPECTIONS:** Written and signed confirmation may be required from you as space holder/s, that any temporary structures, vans equipment etc and any activity that takes place on or adjacent to your site, complies in all respects with all Workplace Health and Safety Legislation. By agreeing to take Space with TPA&MA Inc. You have taken to confirm that you have complied with all Work Health and Safety Legislation for matters that occur on your rented site. This includes, but is not limited to, testing and tagging of all electrical equipment and fitting of earth leakage detection devices if equipment and fitting of earth leakage detection devices if equipment is not double insulated. You also warrant you follow safe work procedures and correct legal procedures to handle flammable gases and chemicals. **You are also required to report all accidents and/or dangerous occurrences to the TPA&MA Inc. Safety Officer and/or Space Steward.** In the event of an accident/accident/dangerous situation, you will be required to complete a written statement as part of the TPA&MA Inc. Incident reporting procedure.

**17. LIQUOR LICENSING LAWS:** You are taken to confirm that you will comply with all Liquor Licensing Legislation regarding consumption of alcohol on the Showgrounds, there is a designated drinking area as defined in the TPA&MA Inc. Liquor Licence and it is defined around the bar area by way of barricades and fencing. Please consume all liquor in that designated areas and not your trade site. Please be aware Liquor Licensing Legislation does not allow you to "shout" your customers or friends a drink at your trade site. If you or your employees become drunk, disorderly or alcohol affected and abusive then the TPA&MA Inc. will call security and/or police and have you removed from the Showgrounds.

**18. SMOKING POLICY:** TPA&MA Inc. Follows Queensland's guide lines in offering a smoke free environment where possible. All areas where food is prepared and eaten, and inside enclosed buildings or a radius from building opening are smoke free zones. Signs will be placed around the grounds indicating smoke free areas. We encourage you not to smoke while you are in the Showgrounds.

**19. PRIVACY:** It is TPA&MA Inc. Usual practise to collect private information from you during the course of the Charters Towers Annual Show trade application and entry process. We only use your personal information for the purpose for which you give it to us and for related internal management purpose. We do not give information about you to government agencies, organisations or anyone else unless one of the following applies: you have consented you'd expect us to or we have told you we will i.e. Show results or publicity, and names may be published; it is required or authorised by law; it will prevent or lesson a serious and imminent threat to somebody's life or health or; the disclosure is reasonably necessary for law enforcement or for the protection of public revenue.
